

# What is Privatization?



## **Privatization Defined**

The shifting of the production of a good or the provision of a service from government to the private sector.

"For the purpose of subcontracting the City chooses to implement, the City may transfer employees involuntarily (a) to another job assignment in their classification or (b) to another classification assignment which will not cause a constructive discharge (i.e. a job which the employee cannot perform) or reasonable change in working conditions fro that employee. The involuntarily transferred employee will not lose pay or 40 hours of regular work per week."

# **Street Lighting**

- Privatized 1990
- Multiple bidders
- Outdoor Lighting Retained contract until 1998
- Contract Bid 1998
- Two bidders
- Pieper Electric
- Contract until 2000
- Extended until 2001
- Extra costs & control

2001 Budget presentation recommended returning street lighting in-house Still had vehicles & equipment

- First full year of operating ended June 2003
- Saved over \$25,000
- Continue to monitor expenditures



## **Construction Inspection**

Owners representative on the job

Answers questions from residents

Makes sure contractor is performing proper installations

Makes in-field decisions



## **Construction** Inspection

- 2002 added one construction inspector to staff
- Picked up 750 hours plus of work time not received from Contract inspectors-annually
- Used time to get as-builds unto plans
- More satisfied with level of inspection



#### Street Sweeping


- Privatized in 1984 as part of an omnibus Solid Waste agreement
- 2003 Specifications for Street Sweeping were sent out separately
- Two proposals were received from private contract sweeper companies in addition to City of Milwaukee





## Street Sweeping 2003

- Company A (Wauwatosa handles sweepings)
  - Company B (Wauwatosa handles sweepings)
- City of Milwaukee Hauling & Disposal of sweepings included
  - Did not include cost of disposal of sweepings





• \$ 69, 588\*

• \$ 69, 470.09

 Estimated cost of hauling & disposal \$11,900

### 2004 Street Sweeping

City of Milwaukee

City of Wauwatosa

7% plus increase

Price just under \$75,000

Multipurpose piece of equipment

**Control of Operation** 



Costs with Fringes & increased sweeping \$67,388.26
